A RESOLUTION OF THE MAYOR OF THE CITY OF SAN DIEGO THE AUTHORIZING OF ESTABLISHING TOW AWAY ZONES ON THE 300 BLOCK OF "J" STREET AND 400-435 THIRD AVENUE

WHEREAS, California Vehicle Code section 22507 authorizes local authorities to prohibit or restrict the stopping, parking, or standing of vehicles on streets or highways, or portions thereof, during all or certain hours of the day;

WHEREAS, California Vehicle Code section 22651 authorizes vehicles to be towed whenever such vehicle is parked or left standing where parking has been prohibited by local authorities and have authorized the removal of the vehicles and posted signs giving notice of the removal;

WHEREAS, San Diego Municipal Code section 86.05 authorizes the City Council prohibit parking on any street or potion thereof between the hours of 7:00 A.M. and 7:00 P.M. and authorize the removal of vehicles parked in violation thereof;

AND WHEREAS, the establishment of a tow away zone on the 300 block of J Street and a portion of Third Avenue will facilitate the continuation of the Farmers' Market that has occurred at those locations for a number of years; NOW THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that, pursuant to the authority conferred by and in accordance with the provisions of San Diego Municipal Code

section 86.05, the installation of a tow away zone, effective from 7 A.M. to 2 P.M. on Sundays, located on both sides of the 300 block of "J" Street and on both sides of the 400-435 block of Third Avenue, is hereby authorized.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, BE IT FURTHER RESOLVED, that this action is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines Section 15301 because this action is the minor alteration of an existing facility with no expansion beyond the existing use.


