A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE MAYOR'S RECOMMENDATION TO DENY THE APPEAL OF OFFICER JEFF CHIONE FOR CERTAIN ANNUAL LEAVE BENEFITS.

WHEREAS, on September 11, 2006 the City Council considered the appeal of a denial by the City's Department of Labor Relations of Officer Jeff Chione's claim to certain annual leave benefits [Chione Grievance], pursuant to Step VI of the grievance process established by Article 24, Grievance Procedure of the Memorandum of Understanding between the City of San Diego and the San Diego Police Officers Association; and

WHEREAS, on September 11, 2006 the City's Department of Labor Relations and the Police Officers Association, on behalf of Officer Chione, were given the opportunity to provide documents and to present their views regarding the Chione Grievance; and

WHEREAS, at the September 11, 2006 meeting the City Council directed the City Attorney to prepare a memorandum regarding the Chione Grievance; and

WHEREAS, on September 25, 2006 the City Council reconvened to consider the memorandum of the City Attorney, together with all other evidence heretofore presented in respect of the Chione Grievance, and to make a final determination regarding the appeal; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, where a public hearing was required by law implicating due process rights of individuals affected by the

decision, and where the Council was required by law to consider information at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that, based upon the evidence presented to the City Council, the recommendation of the Mayor is hereby accepted, and the appeal of Officer Chione is hereby denied.
