WHEREAS, the Filipino-American community is celebrating the 100th Anniversary of the first Filipino immigrant to the United States of America; and

WHEREAS, Filipino immigration to the United States of America is comprised of four waves. The First wave consists of the Manilamen who landed in Louisiana in 1787. The Second wave consists of the Sakadas or fFarm workers in Hawaii and the Alaskeros in Alaska. The Third wave consists of those that served in the United States Navy and lastly, the Fourth wave consists of the young professionals such as doctors, nurses, and lawyers who settled mainly on the East Coast; and

WHEREAS, the Filipino-American community makes up ten percent of the total population of San Diego County; and

WHEREAS, the Filipino-American community contributes to the cultural diversity of the City of San Diego through a variety of community support groups and activism, festivals and fairs, along with collaborative efforts with other cultures in San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim the month of October 2006 as "FILIPINO-AMERICAN HERITAGE MONTH" in the City of San Diego.
