RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AGREEING TO HOLD HARMLESS AND DEFEND THE SAN DIEGO ASSOCIATION OF GOVERNMENTS, ACTING AS THE SAN DIEGO REGIONAL TRANSPORTATION COMMISSION, AGAINST CHALLENGES RELATED TO THE CITY OF SAN DIEGO'S TRANSNET FUNDED PROJECTS.

WHEREAS, on November 3, 1987, the voters of San Diego County approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan (87-01); and

WHEREAS, on November 4, 2004, the voters of San Diego County approved the San Diego Transportation Improvement Program Extension Ordinance and Expenditure Plan (04-01); and

WHEREAS, both Ordinances provide that the San Diego Association of Governments (SANDAG), acting as the San Diego Regional Transportation Commission, shall approve a multi-year program of projects submitted by local jurisdictions identifying those transportation project eligible to use transportation sales tax (TransNet) funds; and

WHEREAS, Policy 031 of the SANDAG Board of Directors provides that each local jurisdiction shall agree by resolution to hold harmless and defend SANDAG, acting as the San Diego Transportation Commission, against any challenges related to that local jurisdiction's TransNet projects; and

WHEREAS, on August 4, 2006, the SANDAG Board of Directors approved the City of San Diego's (City) two-year program of TransNet projects for inclusion in the 2006 Regional Transportation Improvement Plan (RTIP), conditioned on the City's compliance with SANDAG Board Policy 031 within sixty (60) days; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City agrees to hold harmless and defend SANDAG, acting as the San Diego Regional Transportation Commission, against challenges related to the City's TransNet funded Capital Improvement Program projects.
