WHEREAS, Article XV, section 260(b) of the City Charter provides that all executive authority, power, and responsibilities conferred upon the City Manager in Article V, Article VII, and Article IX shall be transferred to, assumed, and carried out by the Mayor during the period of time Article XV is operative; and

WHEREAS, Mayor Jerry Sanders proposes that City Water Director Jim Barrett be appointed to complete the remainder of George Loveland's term ending February 24, 2007;

BE IT RESOLVED, by the Council of the City of San Diego, that the appointment by the Mayor of the City of San Diego of City Water Director Jim Barrett, to serve as a member of

the San Diego County Water Authority Board of Directors, for a term ending February 24, 2007,
