WHEREAS, James M. "Jim" Westfall graduated from El Capitan High School, where he was a member of the wrestling team, and then went on to attend Palomar College and receive his Associate in Arts in Electricity as well as an Associate in Arts in Business Management / Supervision. He graduated in 1973 from San Diego City College, San Diego Electrical Joint Apprenticeship four-year program; and

WHEREAS, in 1976, James M. Westfall began work for Bechtel Power Corp., San Onofre Nuclear Generating Station and advanced to General Foreman in the Electrical Department. In 1980, Jim was elected Business Representative for I.B.E.W. Local 569 and served for seven years; and

WHEREAS, James M. Westfall for the past nineteen years, has been employed with San Diego Electrical Training Trust as Administrative Manager/Director of Training. During his tenure, Jim was instrumental in building the Apprenticeship from 300 students with 12 instructors to 13 full-time staff, 1,250 students and 75 instructors; and

WHEREAS, during James M. Westfall's 30-year career, he has served on the National Electrical Training Directors Association, California Apprenticeship Coordinators Association and the Apprenticeship Coordinators Association of San Diego. He has also been awarded the Electrical Industry Progress Award for Leadership and Exemplary Service and the Founder's Trophy for Extraordinary Leadership and Service to the Electrical Industry by the National Electrical Contractors Association, San Diego Chapter; and

WHEREAS, James M. Westfall is currently the Director of Training for San Diego Electrical Training and has been inducted into the California Apprenticeship Hall of Fame on May 4, 2006; and

WHEREAS, James M. Westfall has been married to his wife Cheryl for thirty six years and they have a son, James, who is currently employed as a CPA Manager at Consadine & Consadine and he is married to Melissa; NOW, THEREFORE,

BE IT RESOLVED, by the Mayor and Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends James M. Westfall for his outstanding achievement or receiving the "Johns Fellowship Award 2006" and thanks him for his continued commitment to the community.


