WHEREAS, Karibu - The Center for Social Support and Education (CSSE) is celebrating its 10th anniversary of service to San Diego communities affected by HIV/AIDS by hosting a Red Carpet Affair – A Major HIV Testing Event at the North Park Theater on September 23, 2006; and

WHEREAS, Karibu - The Center for Social Support and Education's mission is to provide a pathway to wellness, wholeness, and prosperity to the underserved, who are impacted by health disparities including HIV/AIDS, and to provide culturally appropriate services to all regardless of race, gender, sexual orientation, health status, or disability; and

WHEREAS, Karibu - The Center for Social Support and Education has three program components that focus on housing opportunities, wellness, and prevention activities to maintain health and well-being, and a self-sufficiency component to provide life skills and job readiness classes to better the lives of its clients; and

WHEREAS, Karibu - The Center for Social Support and Education is responding to the HIV/AIDS epidemic which has become more complex in the past twenty years – an epidemic that now includes increased populations in the African American, Latino, and Asian American communities; women, young adults, persons exposed to HIV/AIDS through heterosexual contact, and incarcerated individuals; and
