WHEREAS, Arthur Ollman, the founding Director, photographer, scholar, and curator of the Museum of Photographic Arts, MoPA, in beautiful Balboa Park, is retiring after 23 years of dedicated service and will be celebrated at a gala tribute at MoPA on November 1, 2006; and

WHEREAS, Arthur Ollman's contributions to the MoPA are significant and long lasting, with his overseeing of the museum's construction, creating programs and lectures, management and operations, and building a permanent collection of over 9,000 objects and a research library of over 20,000 volumes dedicated to the medium of photography; and

WHEREAS, Arthur Ollman, has curated more than 100 exhibitions for MoPA; given numerous classes and lectures at more than 20 universities, museums, and workshops; and has authored numerous essays, articles, catalogues, and scholarly publications; and

WHEREAS, Arthur Ollman is also an accomplished photographer, whose work has been exhibited in more than thirty one-person shows since 1969 in museums throughout the world including the Centre Georges Pompidou, Paris (1979), and the Kodak Salon Gallery, Tokyo (1988); and whose work has also been featured in more than 45 group shows worldwide; and

WHEREAS, Arthur Ollman will start a new chapter in his life as Director of the School of Art, Design and Art History at San Diego State University in mid-August, which will further enrich the arts and culture of our City; and

WHEREAS, Arthur Ollman's professionalism, dedication, and contributions to the cultural fabric of the City of San Diego will endure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends Arthur Ollman for his accomplishments and service to the Museum of Photographic Arts and wishes him all the best in his retirement.

BE IT FURTHER RESOLVED, that November 1, 2006, be and is hereby proclaimed to be "ARTHUR OLLMAN DAY" in the City of San Diego.
