A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH SENIOR COMMUNITY CENTERS TO ADMINISTER THE TRANSITIONAL HOUSING FOR SENIORS PROGRAM.

WHEREAS, the Transitional Housing for Seniors Program [Program] is a City-sponsored effort to provide seniors who are homeless with vouchers to rent rooms at downtown housing facilities; and

WHEREAS, the Program has been in operation since January 2002, and has provided, to date, over 36,000 bed nights for homeless seniors; and

WHEREAS, as part of the Program, the City of San Diego previously entered into a contract with Senior Community Centers of San Diego, a non-profit service provider, to lease rooms for homeless seniors; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to enter into a contract in an amount not to exceed \$282,000 with Senior Community Centers of San Diego to administer the Transitional Housing for Seniors Program, provided that the terms of the contract are approved

as to form and legality by the Office of the City Attorney, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for the City's obligations under the contract are or will be on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore

exempt from California Environmental Quality Act [CEQA] pursuant to the State CEQA
Guidelines Section 15060(c)(3).
