A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE, APPROPRIATION, AND EXPENDITURE OF FUNDS IN THE AMOUNT OF \$282,000 FROM THE FISCAL YEAR 2007 HORTON PLAZA LOW AND MODERATE INCOME HOUSING FUND.

WHEREAS, the City of San Diego has developed the Transitional Housing for Seniors Program [Program], a City-sponsored effort to provide seniors who are homeless with vouchers to rent rooms at downtown housing facilities; and

WHEREAS, as part of the Program, the City plans to enter into a contract with Senior Community Centers of San Diego, a non-profit service provider, to lease rooms for homeless seniors; and

WHEREAS, the Program would lease a total of 37 rooms for homeless seniors; and WHEREAS, additional funding is required to maintain the Program through June 2007; and

WHEREAS, funds are available in the Fiscal Year 2007 Horton Plaza Low and Moderate Income Housing Fund No. 98446; NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the budget for the Senior Transitional Housing Program Fund No. 19658 is

amended by increasing the budget amount by \$282,000 to pay for leasing costs for the Transitional Housing for Seniors Program.

2. That the City Auditor and Comptroller is authorized to appropriate and expend funds from Fund No. 98446 to pay for leasing costs for the Transitional Housing for Seniors Program, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are available.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from California Environmental Quality Act [CEQA] pursuant to the State CEQA Guidelines Section 15060(c)(3).
