DATE OF FINAL PASSAGE OCT 17 2006

A RESOLUTION APPROVING THE COMBINATION OF THE CONTRACTING, PURCHASING AND PURCHASING AND CONTRACTING DEPARTMENTS AND AUTHORIZING THE MAYOR, WITH THE ASSISTANCE OF THE CITY ATTORNEY AND AUDITOR AND CONTROLLER TO PREPARE ALL DOCUMENTS NECESSARY TO EFFECT THIS COMBINATION PURSUANT TO THE BUSINESS PROCESS RE-ENGINEERING ORDINANCE

WHEREAS, on July 31, 2006, the City Council adopted Ordinance No. O-19523 establishing the policy of the City of San Diego to reorganize the departments of the City to improve the level of services to the citizens and to reduce the cost of providing such services [BPR Ordinance]; and

WHEREAS, the Mayor has commenced the Business Process review of all City departments; and

WHEREAS, the Final Report on the Contracts Re-engineering Study [Contracts BPR] to review and re-engineer the City's procurement process was completed in March 2006; and

WHEREAS, the Contracts BPR showed that the City's current purchasing system is duplicative and lacking a centralized tracking and oversight; and

WHEREAS, the Contracts PBR provided recommendations to create the levels of efficiency contemplated by the BPR Ordinance and the Mayor has determined that several of those recommendations, as detailed in the Mayor's Report on the Contracts BPR [Mayor's Report], should be implemented by the City at this time; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that Mayor's Report is accepted.

BE IT FURTHER RESOLVED, that the Auditor and Controller, with the assistance of the City Attorney, be authorized and directed to prepare an ordinance amending the FY 2007 Appropriations Ordinance in accordance with Mayor's Report and for the approval of the City Council.

BE IT FURTHER RESOLVED, that the City Attorney is authorized and directed to prepare any necessary amendments to the Administrative Code to reflect the combination of City departments in accordance with the Mayor's Report and for the approval of the City Council.


