DATE OF FINAL PASSAGE OCT 17 2006

WHEREAS, the American Public Works Association [APWA] is an international, educational, and professional association of public agencies, private sector companies, and individuals dedicated to providing high quality public works projects; and

WHEREAS, the APWA provides a forum in which public works professionals can exchange ideas, improve professional competency, increase the performance of their agencies and companies, and bring important public works-related topics to public attention in local, state and federal arenas; and

WHEREAS, the APWA, at its annual Congress and Exposition, presents awards to the best Public Works of the Year in a variety of categories; and

WHEREAS, the North Torrey Pines Bridge was nominated by the City of San Diego with an overall length of 340 feet and a width of 69-feet-two inches; and

WHEREAS, the North Torrey Pines Bridge's construction and design challenges included the need to maintain traffic along North Torrey Pines Road and building over water while fighting off wave storm surges during the third rainiest year on record; and

WHEREAS, the design team and contractors used complex, state-of-the-art design and construction techniques which not only minimized environmental impacts and local resident disruptions, but also allowed for a very seismically robust structural system; and

WHEREAS, the APWA selected the North Torrey Pines Bridge as its 2006 Transportation Project of the Year for its construction innovation, environmental sensitivity, and its consideration of community input while maintaining safety; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends FCI Constructors, T.Y. Lin International, and the North Torrey Pines Road Bridge City staff. Congratulations to these recipients for providing us with a picturesque bridge that can be crossed consciously and safely. Thank you for bringing pride and prestige to the City of San Diego.

BE IT FURTHER RESOLVED, that October 10, 2006, be and is hereby proclaimed to be "NORTH TORREY PINES ROAD BRIDGE DAY" in the City of San Diego.
