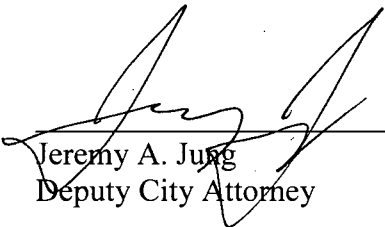
RESOLUTION ADDING C.I.P. 52-759.0, UNIVERSITY AVENUE AND FRONT STREET POP-OUT TO FY 2007 CAPITAL IMPROVEMENTS PROGRAM BUDGET, AND INCREASING, APPROPRIATING, AND EXPENDING FUNDS THEREFOR

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Auditor and Comptroller is authorized to add CIP 52-759.0, University Avenue and Front Street Pop-out to the Fiscal Year 2007 Capital Improvements Program;
2. That the City Auditor and Comptroller is authorized to increase the Fiscal Year 2007 Capital Improvements Program budget in CIP 52-759.0, University Avenue and Front Street Pop-out, Fund 79512, Uptown Urban Community Fund by \$150,000;
3. That the City Auditor and Comptroller is authorized to appropriate and expend \$150,000 from CIP 52-759.0, University Avenue and Front Street Pop-out, Fund 79512, Uptown Urban Community Fund for the purpose of design and construction of the University Avenue and Front Street Pop-out project, contingent upon the City Auditor and Comptroller certifying that funds are available or on deposit in the City Treasury;
4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any to the proper reserves; and

5. That this activity is not a "project" and therefore not subject to CEQA pursuant to State CEQA Guidelines section 15060(c)(2).
