WHEREAS, California Streets and Highways Code Section 8333 (b) and San Diego Municipal Code Section 125.1001(c)(2) provide for the summary vacation of public service easements by City Council where the date of dedication or acquisition is less than five years, and more than one year, immediately preceding the proposed vacation, and the easement was not used continuously since that date; and

WHEREAS, that portion of the sewer easement located in Lot 2 of NTC Unit 4, Map No. 14402, as more particularly described the legal description, marked as attached Exhibit "A", and as shown on Engineering Drawing No. 20410-B, marked and attached as Exhibit "B", and on file in the office of the City Clerk as document Nos. RR- 301964-7 and RR- 301964-7 and RR- 4 dedicated or acquired in 2002 and was not used continuously since that date; and

WHEREAS, there are no other public facilities located within the Easement; and

WHEREAS, the affected property owner has requested the vacation of the unnecessary sewer easement within Lot 2 of NTC Unit 4 Map No. 14402 to unencumber his property and facilitate development of the site; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the sewer easement, either for the purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated;
 - (b) the public will benefit from the vacation through improved utilization of land; and

(c) the public facility or purpose for which the Easement was originally acquired will not be detrimentally affected by this vacation; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Easement is ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.

BE IT FURTHER RESOLVED, that this activity is exempt from CEOA pursuant to State CEQA Guidelines Section 15060(c)(3).


