- 1. That for and on behalf of the City, the Mayor or his designee is authorized to enter into, conduct negotiations for, execute all documents, and comply with all requirements for participation in the demand reduction program administered by Celerity Energy Partners on behalf of San Diego Gas & Electric Company, under the terms and conditions set forth in the Networked Distribution Resource Participation Agreement, on file in the office of the City Clerk as Document No. RR- 301993.
- 2. That Celerity Energy Partners is authorized under the above Networked Distribution Resource Participation Agreement and at no cost to the City, to install particulate matter filters required by the San Diego Air Pollution Control District; to install switchgear equipment; to obtain all required operating licenses and permits; and to provide regular repairs and maintenance for specified generator sites for a period of ten years ending December 31, 2016.
