A RESOLUTION OF THE CITY COUNCIL AUTHORIZING
ADDITIONAL EXPENDITURE FOR THE TECOLOTE
CANYON MITIGATION PROJECT.

WHEREAS, on August 1, 2006, the Council authorized the award of a contract for the construction of the Tecolote Canyon Mitigation Project by Resolution No. R-301790; and

WHEREAS, the low bid received for the Project exceeded the amount previously authorized for expenditure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the additional expenditure of an amount not to exceed \$119,009 from the operating budget of Sewer Fund No. 41509 is hereby authorized, solely and exclusively to provide additional funding for the Tecolote Canyon Mitigation Project construction and contingency.




