BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the City of San Diego be and hereby are authorized and empowered, in compliance with all City and Federal requirements, to select a vendor and to purchase this equipment.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Chief of Police, be and hereby is authorized and empowered, to direct and oversee this purchase, in compliance with the grant program.
