RESOLUTION NUMBER R- 301999

DATE OF FINAL PASSAGE OCT 24 2006

WHEREAS, in August 1905, Reverend William Quinlan of Los Angeles, was sent to San Diego to build the second church in the City of San Diego. At the time, Saint Joseph's Parish, now Cathedral, was the only other parish; and

WHEREAS, on October 8, 1905, services were held at a nearby armory hall for the first time and later the cornerstone of Our Lady's Parish was laid on July 28, 1906; and

WHEREAS, the new Parish with less than forty families held its First Mass on Christmas Day 1906; and

WHEREAS, by 1909, Our Lady of Angels Parish grew to over 100 families and in 1910, a rectory was purchased for the construction of a parish hall and school; and

WHEREAS, Reverend Eugene Heffernan, the second pastor for Our Lady of Angels Church, raised funds through a door-to-door campaign and in September 1912, Our Lady of Angels School, the first parochial school in San Diego, was opened under the care of the Sisters of Saint Joseph Carondelet; and

WHEREAS, in 1917, the predominantly Irish and German community saw the need to start a mission, called La Purisima, to meet the needs of their growing Spanish speaking parishioners which led to the opening of Our Lady of Guadalupe Church in 1921; and

WHEREAS, Reverend William J. Quinlan was assisted by the founding families of George Connell, Jon Conroy, Enrico Guadagnini, Patrick Martin, Max Sick, William Sick, and

Michael Weber on the challenge of helping establish Our Lady of Angels Parish; NOW  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council for and on behalf of the people of San Diego, does hereby commend the Parish for its outstanding service to the people of San Diego.

BE IT FURTHER RESOLVED, that October 8, 2006, be and is hereby proclaimed to be "OUR LADY OF ANGELS CHURCH DAY" in the City of San Diego and
