A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE RELOCATION PLAN FOR THE LA ENTRADA FAMILY APARTMENTS PROJECT IN THE BARRIO LOGAN COMMUNITY PLAN AREA.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Barrio Logan Redevelopment Project [Project]; and

WHEREAS, the real property to be acquired by the Agency contains persons, families and businesses which will or may be displaced [displacees] as a result of the acquisition of the property by the Agency; and

WHEREAS, the State of California's Housing and Community Development regulations (Title 25, Cal. Admin. Code Section 6038) state that prior to proceeding with any displacement, a public entity shall prepare a relocation plan and submit it to the local legislative body (i.e., the City Council) for approval; and

WHEREAS, the Relocation Plan identifies all of the possible residential and nonresidential displaces within the footprint of the La Entrada Family Apartments Project and describes the benefits which will be afforded the displacees in accordance with State Relocation Law and the State Relocation Assistance Guidelines; and

WHEREAS, an advisory notice was sent in a general mailing to all residents and property owners within the footprint of the project stating that the completed relocation plan was made available for public review at the Agency's office, the office of Overland, Pacific & Cutler, the Downtown Central Library and on the Agency's website; and the relocation plan was presented to the Barrio Logan Redevelopment Project Area Committee; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that it approves the Relocation Plan for the La Entrada Family Apartments Project, a copy of which is on file in the Office of the City Clerk as Document No. 0402/

BE IT FURTHER RESOLVED, that this activity is not a "project" and therefore exempt from CEQA pursuant to State CEQA Guidelines Section 15060(c)(3).
