A RESOLUTION APPROVING THE CREATION OF GROUP INFORMATION TECHNOLOGY MANAGERS AND AUTHORIZING THE MAYOR, WITH THE ASSISTANCE OF THE CITY ATTORNEY AND AUDITOR AND COMPTROLLER TO PREPARE ALL DOCUMENTS NECESSARY TO EFFECT THIS RESTRUCTURING PURSUANT TO THE BUSINESS PROCESS RE-ENGINEERING ORDINANCE

WHEREAS, on July 31, 2006, the City Council adopted Ordinance No. O-19523 establishing the policy of the City of San Diego to reorganize the departments of the City to improve the level of services to the citizens and to reduce the cost of providing such services [BPR Ordinance]; and

WHEREAS, the Mayor has commenced the Business Process review of all City departments; and

WHEREAS, the Final Report on the Information Technology Re-engineering Study [IT BPR] to review and re-engineer the City's information technology organization has been completed; and

WHEREAS, the IT BPR showed that the City's current information technology organization lacks a centralized organization and governance process, making structural re-engineering impossible; and

WHEREAS, the IT PBR provided recommendations to create an organization that will allow ongoing efforts to re-engineer the City's information technology processes and functions. These recommendations will allow the levels of efficiency contemplated by the BPR Ordinance

and the Mayor has determined that several of the recommendations, as detailed in the Mayor's Report on the IT BPR [Mayor's Report], should be implemented by the City at this time; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor's Report is accepted.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller, pursuant to Section 2 of the BPR Ordinance, is authorized to adjust expenditure and revenue appropriations as detailed in the Mayor's Report.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller, with the assistance of the City Attorney, is authorized and directed to prepare an ordinance amending the FY 2007 Appropriations Ordinance in accordance with Mayor's Report and for the approval of the City Council.

BE IT FURTHER RESOLVED, that the City Attorney is authorized and directed to prepare any necessary amendments to the Administrative Code to reflect the restructuring of City departments in accordance with the Mayor's Report and for the approval of the City Council.
