DATE OF FINAL PASSAGE DEC 01 2006

WHEREAS, in January 2004, the City of San Diego pass a resolution (R2004-721) to collaborate with the County to develop a “Ten year Plan to End Chronic Homelessness,”; and

WHEREAS, the County, the City, and the United Way subsequently entered into a Memorandum of Agreement to develop a regional plan; and

WHEREAS, the Plan focuses on a Housing First/Housing Plus model, and Prevention, and;

WHEREAS, various stakeholders, both private sector and public agency are joined in this collaboration, with the United Way as the lead agency; and

WHEREAS, a Draft Implementation Plan was developed and presented to the full City Council on October 23, 2006; NOW THEREFORE

BE IT RESOLVED that the City Council accepts the Draft Implementation Plan, and supports the United Way’s further development of the Implementation Plan, with direction to include persons with disabilities on the appropriate boards and committees, and further requesting the United Way return to the full City Council with its final plan to end chronic homelessness.
