A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING THE EXPENDITURE OF FUNDS; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications for the Barrett Reservoir Outlet Tower Upgrade [Project], on file in the office of the City Clerk as Document No. <u>W.O.186151</u>, are approved.
- 2. That, after advertising for bids in accordance with law, the Mayor or his designee is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$1,602,350.00, provided that the City Auditor and Comptroller first furnishes a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. That the expenditure of an amount not to exceed \$1,602,350.00 from Water Fund 41500, CIP 73-317.0, Barrett Reservoir Outlet Tower Upgrade is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate certifying that the funds are, or will be, on deposit with the City Treasurer.
- 4. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$118,547.56 from Water Fund 41500 Unallocated Reserve (Organization 1041, Object Account 4903) to Water Fund 41500, CIP 73-317.0, Barrett Reservoir Outlet Tower Upgrade

and to increase the Fiscal Year 2007 Capital Improvements Program Budget in Water Fund 41500, CIP 73-317.0, Basset Reservoir Outlet Tower Upgrade by \$118,547.56.

- 5. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
- 6. That this activity is exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines Section 15302, as the repair and maintenance of existing facilities.
