DATE OF FINAL PASSAGE NOV 03 2006

GRANT FROM THE U.S. DEPARTMENT OF JUSTICE, VIA
THE BUREAU OF JUSTICE ASSISTANCE TO UPGRADE
AND ENHANCE WIRELESS INTERCOMMUNICATION.

WHEREAS, the City of San Diego Police Department wishes to submit an application to the U.S. Department of Justice, via the Bureau of Justice Assistance, for the COPS 2006 Law Enforcement Technology grant program; and

WHEREAS, the funds will be used to upgrade and enhance wireless intercommunications; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor (or his designee) be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to apply for, accept and expend these grant funds from the U.S. Department of Justice.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to accept, appropriate and expend \$98,723 in grant funds, when the grant is officially authorized by the U.S. Department of Justice, Community Policing Services.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the Mayor (or his designee) to execute all aspects of program operation, including any amendments, extensions, or renewals, for a period of up to five years, provided funding is made available by the State of California, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program.

BE IT FURTHER RESOLVED, that the Council hereby authorized the Chief of Police to administer and operate this program; and that this authorization shall include all purchases and acquisitions necessary to the successful implementation of the grant project;

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement, and not to supplant expenditures controlled by this body.


