WHEREAS, California Streets and Highways Code Section 8333 (b) and San Diego Municipal Code Section 125.1010(c)(2) provide for the summary vacation of public service easements by City Council where the easement to be vacated was dedicated or acquired less than five years ago and more than one year ago and has not been used continuously since that date, and

WHEREAS, that portion of the general utility and access easement located in Lot 37 of Carmel Valley Neighborhood 10, Unit 12 South, Map No. 15067, as more particularly described the legal description, marked as attached Exhibit "A", and as shown on Engineering Drawing No. 20508-B, marked and attached as Exhibit "B", and on file in the office of the City Clerk as document Nos. RR
and RR
[Easement], which are by this reference incorporated herein and made a part hereof, was acquired less than five years ago and more than one year ago; and

WHEREAS, the Easement has not been used continuously since the date of acquisition, there are no other public facilities located within the Easement, and the Easement is no longer required by the City; and

WHEREAS, the Easement vacation is being requested by the affected property owner as part of a private development project, and such vacation will primarily benefit the developer's property and facilitate further development of the site; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a

public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, the City Council finds that:

- (a) there is no present or prospective use for the general utility and access easement, either for the purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated;
- (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the public facility or purpose for which the Easement was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Easement is ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with attached exhibits, attested by him under seal, to be recorded in the Office of the County Recorder.


