WHEREAS, the Catalyst of the Year award was created in 2002 by Community Catalysts to honor people and/or organizations that go above and beyond what is necessary to help disabled San Diegans; and

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends Torrey Pines Kiwanis Club for being the 2006 recipient of the Catalyst of the Year Award. Congratulations to Torrey Pines Kiwanis Club for 24 years of charity, assistance, and service dedicated to not only disabled communities, but all of San Diego's inhabitants.
