DATE OF FINAL PASSAGE NOV 03 2006

WHEREAS, St. Therese Parish was established in 1956 and the church was dedicated in 1959 by the Most Reverend Charles Buddy; and

WHEREAS, in 1960, Sr. Constance and Divine Sisters of Charity moved into the new convent and St. Therese Academy opened with four classrooms. Tuition was \$10 per student or \$25 per family per month; and

WHEREAS, in 1972, the Italian Catholic Federation was established and, in 1981, the Knights of Columbus were established; and

WHEREAS, by 1999, the Youth Group expanded to include "Life Mass," Teen House of Prayer and house building in Mexico. The 55-Plus Club was established and the Comforting Hearts was established to serve ill and recently bereaved; and

WHEREAS, Monsignor Fredrick Floreck was appointed pastor in 1990; and

WHEREAS, Deacon Leo T. Dube retired from active ministry at the age of 87 on December 31, 2005. Deacon Leo performed 27 years of faithful service; and

WHEREAS, the Parish serves 4587 parishioners from throughout the San Diego community. St. Therese Charities was established in 2006 to help those in need in the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, recognizes and salutes the St. Therese Parish and its dedicated parishioners for being a valuable church in the community.

BE IT FURTHER RSOLVED, that the 1st of October 2006 be and is hereby proclaimed to be "ST. THERESE PARISH DAY" in the City of San Diego.
