WHEREAS, California Government Code section 53646 provides that the City Treasurer shall annually render to the City Council a statement of investment policy which the City Council will consider at a public meeting; and

WHEREAS, pursuant to California Government Code section 53600 *et seq.* authority to invest or reinvest funds of the City or to sell or exchange securities purchased shall be vested in the City Council; and

WHEREAS, under California Government Code section 53607, the City Council may delegate the authority to invest or reinvest funds of the City to the City Treasurer for a period of one year, and

WHEREAS, in November 21, 2005, Council delegated investment authority to the Treasurer for a period of one year and the delegation ends on November 21, 2006; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Treasurer's Investment Policy for the Pooled Investment Fund dated October 2006, on file in the office of the City Clerk as Document No. RR- 302036, is hereby received and accepted.

BE IT FURTHER RESOLVED, that the authority to invest or to reinvest the City's operating and capital improvement funds is hereby delegated to the City Treasurer for a period of one year from the date of the adoption of this Resolution provided, however, that the Treasurer shall make monthly reports to this City Council about such transactions.
