BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,500,000 from Sewer Revenue Fund No. 41506 is authorized, solely and exclusively to provide funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for this expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,000,000 from Water Fund No. 41500 is authorized, solely and exclusively to provide funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for this expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to return any unexpended funds to the appropriate reserve upon the advice of the administering departments.

BE IT FURTHER RESOLVED, that this activity is categorically exempt from the California Environmental Quality Act pursuant to CEQA Guideline section 15301(c), repair and maintenance of existing streets.
