RESOLUTION OF THE CITY COUNCIL AUTHORIZING A CHANGE ORDER FOR THE INSTALLATION OF A BRIDGE AT THE ROUTE 252 CORRIDOR (PETWAY) PARK; AUTHORIZING EXPENDITURES; AND FINDING NO ENVIRONMENTAL IMPACT BY THIS ACTION.

WHEREAS, the general development plan for the State Route 252 Corridor Park, also known as Petway Park, includes a pedestrian and emergency vehicle bridge across Chollas Creek; and

WHEREAS, the construction contract was advertised without the bridge because at the time, the funding for both the park and the bridge was inadequate; and

WHEREAS, after the bidding process for the park was completed, the California

Department of Parks and Recreation announced the award of a grant to the City sufficient to pay
for both the park and the bridge; and

WHEREAS, the San Diego Police Department indicates the bridge is needed immediately to ensure adequate response times to both sides of the park and new residential development immediately adjacent to the park; and

WHEREAS, City staff estimates that this proposed change order will save the City at least \$100,000 in costs and have the bridge in place two years sooner compared to the time and money it would cost to construct the bridge under a separate contract; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, a change order with The Heffler Company, for the purchase and installation of a bridge at the Route 252 Corridor (Petway) Park,

under the terms and conditions set forth in the change order, on file in the office of the City Clerk as Document RR-___302049.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$452,281.00 from CIP 29-458.0, Route 252 Corridor (Petway) Park, is authorized solely and exclusively for the above change order.

BE IT FURTHER RESOLVED, that this action is categorically exempt from the California Environmental Quality Act pursuant to CEQA guidelines section 15303, new construction or conversion of small structures.
