WHEREAS, the City of San Diego on August 5, 2002, approved an "as needed" consultant agreement with Richard Brady and Associates in Resolution No. R-296923; and

WHEREAS, the agreement was for a term of 2 years and an amount not to exceed \$2,000,000 for all tasks; and

WHEREAS, on June 21, 2004, the City of San Diego amended the original agreement, on file with the City Clerk as Document No. C-12721, for an additional three years and no additional funding; and

WHEREAS, the agreement was for planning and design services for both water and sewer projects; and

WHEREAS, funding for the agreement was broken down between the appropriate water and sewer funds, with an amount not to exceed \$400,000 from water fund 41500, and an amount not to exceed \$1,600,000 from sewer fund 41506; and

WHEREAS, at this time there is a need for the consultant to do more design work on water projects compared to sewer projects, therefore requiring a change in the funding allocation; and

WHEREAS, even with the reallocation of funds for this agreement, the overall amount previously authorized of \$2,000,000 will not be increased; NOW THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego, that the Auditor and Comptroller is authorized to increase the expenditure from \$400,000 to an amount not to exceed \$700,000 from water fund 41500 and decrease the expenditure from \$1,600,000 to an amount not to exceed \$1,300,000 from sewer fund 41506 for the purpose of planning and designing

services for water and sewer projects, provided the City Auditor first furnishes a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not subject to California Environmental Quality Act (CEQA) pursuant to state CEQA guidelines sections 15060(c)(3) and 150378(b)(4).
