WHEREAS, on June 21, 2006, the City Attorney's Office received notification from the State Agency that the City's grant had been amended to increase the amount by \$3,668.01 (from \$146,720.40 to \$150,388.41); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney's Office is hereby authorized to accept \$3,668.01 in additional grant funding from the State Agency to fund the Criminal Restitution Compact Restitution Specialist position for the time period of July 1, 2005 through June 30, 2007, under the terms and conditions outlined in the Standard Agreement Number VCGC5073 between the State Agency and the City Attorney's Office, a copy of which is on file in the City Clerk's Office as Document No. 2055.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the City Attorney's Office is authorized to execute all aspects of the program operation, including any amendments, extensions, or renewals, and to certify that the City will comply with all applicable

statutory or regulatory requirements related to said program to the Victim Compensation Grant Agreement.

BE IT FURTHER RESOLVED, that the City of San Diego hereby agrees to hold the State Agency of the State of California harmless from any liability arising out of the performance of the grant agreement, including court actions or damages, and certifies that the City will not use the grant to supplant local expenditures.
