RESOLUTION NUMBER R- 302057
DATE OF FINAL PASSAGE NOV 22 2006

BE IT RESOLVED, by the Council of the City of San Diego as follows:


1. That the Mayor, or his representative, is authorized and empowered for and on behalf of the City to make an application to the California Department of Transportation [Caltrans] for \$500,000 in Bicycle Transportation Account [BTA] funds.
2. That the Mayor or his representative is authorized and empowered to take all necessary actions to secure the funding from Caltrans for the purpose of improving safety and convenience for bicycle commuters.
3. That the City Auditor and Comptroller is authorized to accept, appropriate, and expend funds if grant funding is secured.
4. That the City Auditor and Comptroller is authorized to establish a special interest-bearing fund for the grant.
5. That the City Auditor and Comptroller is authorized to increase the Fiscal Year 2007 Capital Improvements Program Budget in CIP 58-147.0, Rose Creek Bikeway, Fund 38373, Rose Creek Bikeway BTA by \$500,000.
6. That the City Auditor and Comptroller is authorized to appropriate and expend \$500,000 from CIP 58-147.0, Rose Creek Bikeway, Fund 38373, Rose Creek Bikeway BTA for the purpose of improving connectivity and creating a safe and convenient bicycle route across Rose Creek for bicycle commuters, contingent upon receipt of a fully executed program supplement and upon the Auditor and Comptroller certifying that funds are on deposit in the City Treasury.

7 That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess funds if any to the appropriate reserves.

8. That this activity is exempt from CEQA pursuant to CEQA Guidelines section 15060(c)(2) because it will not result in a direct or reasonably foreseeable indirect physical change in the environment.
