A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPLICATION FOR AND EXPENDITURE OF STATE GRANT FUNDS FOR THE MISSION TRAILS REGIONAL PARK COWLES MOUNTAIN TRAIL REHABILITATION PROJECT.

WHEREAS, the "Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users" provides funds to the State of California for Grants to state, local and non-profit organizations to acquire, develop and/or maintain motorized and non-motorized trail purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing Project Application under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the Applicant to certify by resolution the approval of an application before submission of said application to the State; and

WHEREAS, the Applicant will enter into a Contract with the State of California to complete the Project; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his representative is authorized to apply to the State of California for a Recreational Trails Program Grant Program for Mission Trails Regional Park Cowles Mountain Trail Rehabilitation Project [Project].

2. That the Mayor or his representative is authorized on behalf of said City, to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the project.

3. That the City Auditor and Comptroller is authorized to accept, appropriate and expend funds, contingent upon receipt of fully executed grant agreement.

4. That the City Auditor and Comptroller is authorized to establish a special interest-bearing fund for the Grant, contingent upon receipt of fully executed grant agreement.

5. That the Fiscal Year 2007 CIP Budget is amended by adding \$100,000 to CIP No. 29-910.2 Mission Trails Regional Park Cowles Mountain Trail Restoration Project, contingent upon receipt of fully executed grant agreement.

6. That the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$100,000 from CIP No. 29-910.2, Mission Trails Regional Park Cowles Mountain Trail Restoration Project, contingent upon receipt of a fully executed grant agreement.

7. That the City Council certifies that it has or will have available prior to commencement of any work on the project included in this application, sufficient funds to operate and maintain the project.

8. That the City Council certifies that the Grantee has reviewed, understands, and agrees to the general provisions contained in the contract shown in the procedural guide.

9. That the City Council agrees to comply with all applicable federal, state, and local laws, ordinances, rules, regulations and guidelines.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA Guidelines pursuant to CEQA Section 15301.
