DATE OF FINAL PASSAGE NOV 22 2006

WHEREAS, the Community Forest Advisory Board (formerly the Tree Advisory Board) is established in San Diego Municipal Code section 26.0501 to advise the Mayor, City Council, and City Manager on policy issues relating to urban forestry; and

WHEREAS, the Municipal Code provides that the Board shall consist of fourteen members appointed by the Mayor and confirmed by the City Council who represent the following: one member who shall be designated as the Chairperson; eight members, one each from a list of two nominations submitted by each Council member to represent their district; and the Mayor shall appoint five members who shall be a Landscape Architect, a Certified Arborist/Urban Forester; a Horticulturist/Nursery Industry representative; a People for Trees representative; and an Artist; and

WHEREAS, the members shall serve three year terms and each member shall serve until a successor is duly appointed and confirmed; and

WHEREAS, the members shall be appointed such that the terms of not more than five members shall expire in any year; and

WHEREAS, there is one vacancy on the Community Forest Advisory Board due to the resignation of Nancy J. Hughes, whose term expires December 31, 2007, NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the Community Forest Advisory Board, for a term ending as indicated, be and the same is hereby confirmed:
