BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby salute the work of SAN DIEGO LISC for outstanding service, leadership, and commitment to area residents and neighborhoods in honor of its 15th anniversary and its tremendous accomplishments.
