DATE OF FINAL PASSAGE NOV 22 2006

WHEREAS, the HILLCREST CLEAN T.E.A.M. celebrates its first anniversary with a Hillcrest Super Clean-up in collaboration with the Hillcrest Association and Councilmember Toni Atkins on Sunday, November 5th, 2006; and

WHEREAS, for the past year the HILLCREST CLEAN T.E.A.M. has hosted bi-weekly clean-ups of the Hillcrest business areas through rain and shine, and accomplished numerous clean-ups utilizing all-volunteer teams that sweep the sidewalks, curbs, and gutters of Hillcrest; and

WHEREAS, the HILLCREST CLEAN T.E.A.M. mission is to keep the neighborhood clean; to raise environmental awareness of visitors, local residents and businesses; and to build a sense of pride in the community; and

WHEREAS, the HILLCREST CLEAN T.E.A.M. has attracted volunteers from all over the county, from teenagers to retired seniors, and organizations such as Francis Parker High School, University of California, San Diego, San Diego State University, Mission Hills Garden Club, Uptown Sunrise Rotary Club, and the Imperial Court de San Diego, to name a few; and

WHEREAS, the HILLCREST CLEAN T.E.A.M. has also garnered the support of various businesses that have contributed prizes, refreshments, and equipment for these clean-ups; and

WHEREAS, the HILLCREST CLEAN T.E.A.M. has consistently averaged approximately 20 volunteers per clean-up and frequently collects over 20 bags of trash at each volunteer event with volunteer ranks growing to over 85 members; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize the accomplishments of the Hillcrest CLEAN T.E.A.M., its volunteers, and coordinator Cathy Lee; and commends the organization for its efforts to clean and beautify the community of Hillcrest in the City of San Diego.
