A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AND EXECUTION OF AN AGREEMENT AUTHORIZING THE APPLICATION FOR GRANT FUNDS FOR THE 32ND STREET CANYON RESTORATION PROJECT IN THE GREATER GOLDEN HILL COMMUNITY PLANNING AREA.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is hereby authorized and empowered to cosponsor an application to the State of California Department of Water Resources for an Urban Streams Restoration grant for watershed stabilization, flood damage reduction and habitat restoration in 32nd Street Canyon [Project]. The City will act as co-applicant with the Greater Golden Hill Community Development Corporation [GGHCDC] in partnership with the 32nd Street Canyon Task Force.
- 2. That the Mayor or his designee is authorized to take all necessary actions to secure funding from the State of California Department of Water Resources

 Urban Streams Restoration Program, including signing grant contracts.
- 3. That the Mayor or his designee is authorized on behalf of said City, to conduct all negotiations, execute and submit all documents, including by not limited to applications, agreements, amendments, which may be necessary to secure funding and to carry out all obligations, responsibilities and duties of the aforementioned project.
- 4. The Mayor of his designee is authorized to execute an agreement with the GGHCDC, on file with the City Clerk as Document No. RR- 302082, for

GGHCDC to design and construct the Project and implementation of the grant requirements.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA Guidelines pursuant to CEQA Section 15060(c)(3).
