A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE PURCHASE AND INSTALLATION OF SURVEILLANCE CAMERAS AS PART OF THE MID-CITY CRIME REDUCTION INITIATIVE WIRELESS VIDEO SURVEILLANCE SYSTEM.

WHEREAS, the goal of the Mid-City Crime Reduction Initiative Wireless Video Surveillance System is to reduce the level of crime within the Mid-City Community (“Community”); and

WHEREAS, El Cajon Boulevard and University Avenue are major thoroughfares through this Community; and

WHEREAS, street robberies, prostitution, commercial robberies, assaults, graffiti and gang activity are a constant crime issue to residents, business owners and visitors to the Community; and

WHEREAS, radio calls and other priorities in the Mid-City Division of the San Diego Police Department (“SDPD”) do not allow an officer to constantly patrol El Cajon Boulevard and University Avenue; and

WHEREAS, surveillance cameras will provide a mechanism to consistently monitor and address illegal activity on El Cajon Boulevard and University Avenue as well as provide the SDPD with a proactive tool to assist in reducing the level of crime in the Community; and

WHEREAS, SDPD requested funding from tax increment funds from the City Heights Redevelopment Project Area for purchase and installation of four cameras and an antennae to be


installed on El Cajon Boulevard and University Avenue within the boundaries of the City Heights Redevelopment Project Area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council make the necessary findings that the contribution of up to \$70,000 from the City Heights Redevelopment Project Area to the San Diego Police Department for the Mid-City Crime Reduction Initiative Wireless Video Surveillance System is necessary and of benefit to the City Heights Redevelopment Project Area.
2. That the Council accepts the funds of up to \$70,000 for the Mid-City Crime Reduction Initiative Wireless Video Surveillance System.
3. That the Council enters into a Cooperation Agreement for the Mid-City Crime Reduction Initiative Wireless Video Surveillance System.
4. That this activity is not a project and therefore exempt from CEQA pursuant to State CEQA Guidelines 15060(c)(3).
