A RESOLUTION OF THE CITY OF SAN DIEGO AMENDING  
THE PACIFIC HIGHLANDS RANCH PUBLIC FACILITIES  
FINANING PLAN AND FACILITIES BENEFIT ASSESSMENT  
FOR FISCAL YEAR 2006.

WHEREAS, the document titled the "Pacific Highlands Ranch Public Facilities Financing Plan and Facilities Benefit Assessment, Fiscal Year 2006" [Financing Plan] was approved by the Council of the City of San Diego on July 5, 2006; and

WHEREAS, on August 10, 2006, the Council of the City of San Diego passed a resolution designating the area of benefit in Pacific Highlands Ranch, confirming the description of the public facilities project in the Financing Plan, the community financing plan with respect to the public facilities projects, the method for apportioning costs of the public facilities projects among the parcels in the area of benefit and the amount of the facilities benefit assessments charged to each parcel; and

WHEREAS, since the adoption of the Financing Plan, the cost estimate for one of the projects, Fire Station 47, has increased; and

WHEREAS, the City Planning & Community Investment Department would like to reflect the increase in the estimated cost of Fire Station 47 in the Financing Plan; and

WHEREAS, this cost increase will not affect the area of benefit; the amount of facilities benefit assessments charged to each parcel; the type and description of the projects identified in the Financing Plan; the methodology for computing, assessing, and levying the facilities benefit assessments; or the amount of the contribution or advance, if any, which the City or other public entity will make toward the total cost; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Pacific Highlands Ranch Public Facilities Financing Plan and Facilities Benefit Assessment for Fiscal Year 2006 is amended by increasing funding for project F-1, CIP No. 33-105.0, Fire Station 47-Pacific Highlands Ranch, Fund No. 79011, by \$731,200 and re-program reimbursement funding of \$731,200 for project T-4.3, Carmel Valley Road (Pacific Highlands Ranch Parkway to Lopelia Meadows Place) from FY 2007 to FY 2011.


2. That the City Auditor and Comptroller is authorized to appropriate and expend an additional amount not to exceed \$731,200 from Facilities Benefit Assessment [FBA] Fund No. 79011 for CIP No. 33-105.0, Fire Station 47-Pacific Highlands Ranch, contingent upon the Auditor and Comptroller certifying that the funds necessary for said project are, or will be, on deposit with the City Treasurer; subject to revision by subsequent updates to the Financing Plan.

3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA pursuant to the State CEQA Guidelines Section 15060(c)(3).
