WHEREAS, The City of San Diego previously maintained a list of consultants for asneeded services;

WHEREAS, Helix Environmental Planning, Inc. was selected by the City Manager to perform as-needed environmental consulting services for the Streets Division storm channel maintenance program, and was awarded a contract on file with the City Clerk as document C-12906;

AND WHEREAS, Streets Division has determined that the services necessary to support the storm channel maintenance program will exceed \$250,000; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor be and he is hereby authorized and empowered to execute an amendment the October 14, 2004, Agreement for As-Needed Consulting Services and the Long-Term Drainage Maintenance Program with Helix Environmental Planning (Document C-12906), to assist General Services Department Street Division to prepare environmental review documents, secure multiple regulatory authorizations, perform routine maintenance, repair flood control channels and storm drainage facilities citywide in an amount not to exceed \$345,000.

BE IT FURTHER RESOLVED, that an amount not to exceed \$345,000, from the Street Division Operating Fund, Fund No. 100, is authorized solely and exclusively for the purpose of providing funds for this service.

BE IT FURTHER RESOLVED, that the City Council finds that this activity is activity is a government fiscal activity which does not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Sections 15378(b)(4) and 15060(c)(2).
