

RESOLUTION NUMBER R- 302107  
DATE OF FINAL PASSAGE DEC 11 2006

WHEREAS, the San Diego Housing Commission is established in San Diego Municipal Code section 98.0301 to act as a Housing Commission under the Housing Authority Law of the State of California; and

WHEREAS, the San Diego Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the San Diego Municipal Code also provides that of the seven members appointed by the Mayor, two commissioners appointed shall be tenants of Housing Authority units and at least one commissioner so appointed shall be over 62 years of age; and


WHEREAS, the term of office of each member shall be four years, except that the terms of office of the two members who are tenants of Housing Authority units shall be two years as set forth in section 34272 of the Health and Safety Code of the State of California; and

WHEREAS, there are four vacancies on the San Diego Housing Commission due to the resignation of Leeandrus Knight and to the expired terms of Alice Tumminia, Jennifer Adams-Brooks, and Tony Yip, whose terms expired January 2, 2006; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointments by the Mayor of the City of San Diego to serve as members of the San Diego Housing Commission, for terms ending as indicated, be and the same are hereby confirmed:
