A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO RATIFYING THE ELECTION RESULTS OF  
OCTOBER 3, 2006 FOR THE COLLEGE COMMUNITY  
REDEVELOPMENT PROJECT AREA COMMITTEE

WHEREAS, on September 22, 1992, the Council of the City of San Diego ("Council")  
by Resolution No. 280718, adopted the Procedures for the Formation of a Project Area  
Committee ("PAC") for the College Community Redevelopment Project ("Project"); and

WHEREAS, California Community Redevelopment Law requires that a PAC remain in  
existence for three years from the date of adoption of the redevelopment plan; and

WHEREAS, the Council of the City of San Diego has continued to extend the PAC an  
additional year since 1995; and

WHEREAS, the annual election was conducted on October 3, 2006, after notice and  
according to the Project PAC bylaws and procedures enumerated within the documents approved  
by the Council; and


WHEREAS, a representative from the City Clerk's office attended the October 3, 2006,  
election to ensure its validity; and

WHEREAS, the elected members of the Project Area Committee have submitted to this  
City Council information establishing the qualifications of each person relative to district,  
category or organization as appropriate;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, as  
follows:

1. That the College Community Redevelopment Project Area Committee consisting of persons named on the list of Project Area Committee members receiving the highest number of votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.
2. That the Council hereby concurs that the election results of October 3, 2006 are valid and binding in accordance with the procedures so adopted by Resolution No. 280718.
3. That this activity is not a "project" and is therefore exempt from California Environmental Quality Act (CEQA) pursuant to the State CEQA Guidelines Section 15060(c)(3).


