A RESOLUTION APPROVING PLANS AND SPECIFICATIONS; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACT; AUTHORIZING THE EXPENDITURE OF FUNDS; AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications for the construction of Rancho Bernardo Reservoir Rehabilitation [Project], filed in the office of the City Clerk as Document No. W.O. 185691, are approved.
- 2. That, after advertising for bids in accordance with law, the Mayor or his designee is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$8,355,234.00, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$5,000,000 from Water Fund 41500, CIP 75-926.0, Water CIP Reserve, and \$768,167.79 from Water Fund 41500, CIP 70-954.0, North City Reclamation System to Water Fund 41500, CIP 73-328.0, Rancho Bernardo Reservoir Rehabilitation.
- 4. That the expenditure of an amount not to exceed \$8,355,234.00 from Water Fund 41500, CIP 73-328.0, Rancho Bernardo Reservoir Rehabilitation, is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

- 5. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
- 6. That this activity is categorically exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines Section 15302, as the repair and maintenance of existing facilities.
