A RESOLUTION OF THE CITY COUNCIL ACCEPTING THE BID AND AWARDING A CONTRACT TO KEMIRON INDUSTRIES, INC. TO FURNISH FERRIC CHLORIDE FOR WASTEWATER TREATMENT; AND EXPENDING FUNDS FOR SUCH TREATMENT.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the bid of Kemiron Industries, Inc. to furnish ferric chloride for wastewater treatment (Bid No. 8405-07-T), is hereby accepted.
- 2. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a contract with Kemiron Industries, Inc. as may be required for a one-year period from date of award, at a cost not to exceed \$4,792,090 with options to renew the contract for four additional one-year periods, with price escalation not to exceed 25% of prices in effect at the end of each prior contract year, in accordance with the contract on file in the office of the City Clerk as Document No 2125
- 3. That the expenditure of an amount not to exceed \$4,792,090 from Fund No. 41508, Dept 771, is hereby authorized, solely and exclusively to provide funds for the first year of the above contract, and future additional expenditures are authorized contingent on the exercise of each option year and acceptance of the potentially escalated prices by the Metropolitan Wastewater Department, and provided the City Auditor and Comptroller furnishes one or more certificates demonstrating that the funds necessary for additional expenditure are, or will be, on deposit with the City Treasurer.

4. That the above activity is categorically exempt from the California Environmental
Quality Act pursuant to CEQA Guidelines section 15301(b), as the operation of existing sewer
facilities.
