A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RELATING TO GOLF OPERATIONS – MOTIVE EQUIPMENT FUND TRANSFER.

WHEREAS, the Equipment Division of the General Services Department is responsible for the purchase of the city non-public safety motive equipment. Purchases of replacement vehicles are funded by departments paying assignment charges on a bi-weekly basis for every vehicle they operate. The revenue is accumulated and these funds are used to replace vehicles as they become due for replacement; and

WHEREAS, the Golf Operations sub-fund of the Central Garage Equipment Replacement fund has accumulated excess revenue, with the major contributing factor being the former continuation of assignment fee accumulation after a vehicle's life cycle is expired; and

WHEREAS, in order to meet United States Golf Association requirements for maintenance of Torrey Pines Golf Course prior to the 2008 U. S. Open Golf Championship, Golf Operations plans to use the accumulated vehicle assignment charges to acquire equipment and vehicles not maintained by General Services Department; and

WHEREAS, the requested action will not affect the current replacement schedule for Golf Operations vehicles; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$400,000 from Central Garage Equipment Replacement Fund No. 500317, Account No. 95303, to Golf Operations Fund No. 41400, and Account No. 78510.

2. That the City Auditor & Comptroller is authorized to appropriate and expend an amount not to exceed \$400,000 from the Golf Operations Fund No. 41400, for the purpose of acquiring equipment and vehicles not purchased or maintained by the General Services

Department for golf course improvements.

3. That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
