A RESOLUTION ACCEPTING GRANT FUNDING FROM THE INDIAN GAMING LOCAL COMMUNITY BENEFIT COMMITTEE IN THE AMOUNT OF \$170,000 AND AUTHORIZING THE APPROPRIATION OF SAME FOR THE PROCUREMENT OF DIGITAL MICROWAVE DOWNLINK EQUIPMENT FOR THE AIR OPERATIONS DIVISION OF THE FIRE-RESCUE DEPARTMENT

WHEREAS, the Indian Gaming Local Community Benefit Committee ["IGLCBC"] grants monies to local entities and agencies impacted by tribal gaming; and

WHEREAS, the City, through its Fire-Rescue Department and Corporate Partnership Program ["CPP"], has previously submitted and been awarded grant funds for equipment and operational needs from the IGLCBC; and

WHEREAS, the City, through its Fire-Rescue Department and CPP submitted a 2006 Grant proposal and was awarded the amount of \$170,000 from the IGLCBC for the procurement of digital microwave downlink equipment (microwave receivers and support equipment) for its Air Operations Division; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor is authorized to execute a grant agreement, and pursuant thereto accept on behalf of the City of San Diego grant funding in the amount of \$170,000 from IGLCBC for the procurement of digital microwave downlink equipment for the Fire-Rescue Department's Air Operations Division.

BE IT FURTHER RESOLVED that the Auditor and Comptroller is authorized to appropriate and expend the grant funds for the procurement of digital microwave downlink equipment for the Fire-Rescue Department's Air Operations Division.
