DATE OF FINAL PASSAGE NOV 28 2006

WHEREAS, each year, the City Council adopts a schedule of meetings for the City Council and Standing Committees of the City Council for the calendar year, commonly referred to as the legislative calendar; and

WHEREAS, this year, in addition to the regularly scheduled City Council and Standing Committees meetings listed on the legislative calendar, the Budget Review Committee meetings have been added and designated as "Council Budget Hearings" to avoid confusion with the Budget and Finance Committee meetings; and

WHEREAS, the first Council Budget Hearing would be scheduled for January 17, 2007, as a "visioning" workshop in anticipation of the Council's requirement to provide its goals for the upcoming budget to the Mayor, and such meeting would be chaired by the Budget and Finance Committee chair; and


WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of meetings for the City Council, Standing Committees, and Council Budget Hearings of the City Council for the period of January 1, 2007, through December 31, 2007, a copy of which is on file

in the Office of the City Clerk as Document No. RR- 302134, be and the same is hereby adopted.

BE IT FURTHER RESOLVED, that the first Council Budget Hearing on January 17, 2007, will be chaired by the Budget and Finance Committee chair.
