WHEREAS, Gene Trepte will be honored by the Friends of Balboa Park with a 2006 Millennium Award for many years of exceptional efforts in leadership and volunteerism in Balboa Park; and

WHEREAS, on Tuesday, November 14, 2006, the Friends of Balboa Park will host the sixth annual Millennium Awards Luncheon at the Balboa Park Club, will celebrate this year's theme, *Balboa Park: Honoring the Legacy*, and will honor two individuals who have been outstanding stewards of Balboa Park's legacy – Gene Trepte and Darlene Davies; and

WHEREAS, Gene Trepte's dedication and commitment to Balboa Park is inspired by his family's involvement dating back three generations when his grandfather oversaw the WPA effort for Balboa Park's 1935 California-Pacific International Exposition; and

WHEREAS, Gene Trepte served as a trustee to the San Diego Zoological Society for forty-eight years, and was a founding director of the San Diego Automotive Museum in Balboa Park; and

WHEREAS, Gene Trepte helped the Old Globe, after the disastrous fire of 1978, by raising funds, by re-building the Old Globe Theatre, and by serving as a member of the board of directors; and

WHEREAS, Gene Trepte endeavors to ensure Balboa Park's future through his support and participation in the Balboa Park Endowment Committee of the San Diego Foundation, the Balboa Park Advisory Committee, and the Trepte Family Balboa Park Fund, of The San Diego Foundation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends Gene Trepte for his longstanding commitment to and support of Balboa Park and of civic and charitable organizations in the City of San Diego, and congratulates him on his receipt of the Friends of Balboa Park's sixth annual Millennium Award.
