WHEREAS, Grant Hill Partners, LLC., Owner/Permittee requested an amendment to the Progress Guide and General Plan and the Southeastern San Diego Community Plan to redesignate an approximate 5,000 square foot parcel from Neighborhood Commercial to Residential (10-15 dwelling units per acre), located on the 500 block of 30th Street on the west side of the street, north of Island Avenue and south of Market Street and legally described as Lot 10 of Block 7, Map 29 Hoitt's Addition; and

WHEREAS, the Planning Commission of the City of San Diego held a public hearing for the purpose of considering an amendment to the Progress and Guide and General Plan and the Southeastern San Diego Community Plan; and WHEREAS, the Planning Commission of the City of San Diego found the proposed amendment consistent with the Progress Guide and General Plan and Southeastern San Diego Community Plan; and

WHEREAS, the Council of the City of San Diego has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it adopts the amendment to the Southeastern San Diego Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR- 302142.

BE IT FURTHER RESOLVED, that the Council adopts an amendment to the Progress Guide and General Plan for the City of San Diego to incorporate the above amended plan.
