WHEREAS, Marcia Samuels as the Neighborhood Code Compliance Department Director, was instrumental in developing new citywide processes and ordinances to improve the quality of life for San Diego's citizens, visitors, and businesses; and

WHEREAS, Marcia Samuels was recently tapped by Mayor Sanders to develop the new Customer Service Department to improve service delivery to the citizens of San Diego; and


WHEREAS, Marcia Samuels has served as a leader, mentor, friend, and confidante to many City employees; and
